

## **Minutes of Meeting Tuesday, October 21, 1997**

**Approval of Minutes of September 18, 1997, Board Meeting** - Upon the recommendation of Superintendent Ringo and a motion of Mrs. Villwock, seconded by Mr. Held, the board voted and the motion carried to approve the minutes of the September 18, 1997, board meeting.

**Financial Statement** - Mr. Byrer read the financial statement for the month of September.

**Approval of Claims and Authorization for Payment** - Payroll Numbers 2 & 3 and Claim Numbers 1141-1287. Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mrs. Villwock, the board voted and the motion carried to approve and authorize payment of payroll numbers 2 and 3 and claim numbers 1141-1287.

**Employment of Assistant Varsity Wrestling Coach** - Upon the recommendation of Superintendent Ringo and a motion of Mr. Held, seconded by Mrs. Villwock, the board voted and the motion carried to employ David Anderson as Assistant Varsity Wrestling Coach.

**Employment of 8th Grade Boys' Basketball Coach** - Upon the recommendation of Superintendent Ringo and a motion of Mrs. Villwock, seconded by Mr. Rode, the board voted and the motion carried to employ Max Nickless as 8th Grade Boys' Basketball Coach.

**Employment of 8th Grade Girls' Basketball Coach** - Upon the recommendation of Superintendent Ringo and a motion of Mr. Held, seconded by Mr. Sargent, the board voted and the motion carried to employ Charlene Grove as 8th Grade Girls Basketball Coach.
