Review of Buddy Computer Bids - Superintendent Ringo stated the original company the bid was awarded to could not financially meet the obligations of his bid. Therefore, it was necessary to award the bid to the second lowest bidder. Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mrs. Villwock, the board voted and the motion carried to award the bid to Bilimoria Computer Systems in the amount of \$293,400.00.

Approval of High School Student Handbook - Upon the recommendation of Superintendent Ringo and a motion of Mr. Held, seconded by Mr. Rode, the board voted and the motion carried to approve the high school student handbook as presented.

Approval of Elementary and Junior High Student Handbook - Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mrs. Villwock, the board voted and the motion carried to approve the elementary and junior high student handbooks as presented.

Employment of Junior High Math Teacher - Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mrs. Villwock, the board voted and the motion carried to employ Bonnie Organ as Junior High Math Teacher.

Employment of Football Coaches - Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mr. Held, the board voted and the motion carried to employ Greg Kyle and Steve Keyes as Assistant Varsity Football Coaches; Jim Beery as Freshman Football Coach; Kenny Bilskie as Assistant Freshman Football Coach and Tim Grove and Greg Kyle as Junior High Assistant Football Coaches.

Employment of Varsity and Junior Varsity Cheerleading Sponsor - Upon the recommendation of Superintendent Ringo and a motion of Mrs. Villwock, seconded by Mr. Sargent, the board voted and the motion carried to employ Bonnie Organ as Varsity and Junior Varsity Cheerleading Sponsor.

Resignation of Girls Cross Country Coach - Upon the recommendation of Superintendent Ringo and a motion Mrs. Villwock, seconded by Mr. Sargent, the board voted and the motion carried to accept the resignation of Andrea Ford as Girls Cross Country Coach.

Employment of Freshman Volleyball Coach - Upon the recommendation of Superintendent Ringo and a motion of Mrs. Villwock, seconded by Mr. Rode, the board voted and the motion carried to employ Andrea Ford as Freshman Volleyball Coach.

Employment of Girls Cross Country Coach - Upon the recommendation of Superintendent Ringo and a motion of Mrs. Villwock, seconded by Mr. Held, the board voted and the motion carried to employ Rhonda Hunt as Girls Cross Country Coach.

Employment of Part-Time Matron(s) - Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mr. Sargent, the board voted and the motion carried to employ Anita Sue Farley as part-time matron at West and Delinda Hambrick as part-time matron at East.

Employment of Freshman Cheerleading Sponsor - Upon the recommendation of Superintendent Ringo and a motion of Mr. Sargent, seconded by Mrs. Villwock, the board voted and the motion carried to employ Kristi Buckthal as Freshman Cheerleading Sponsor.

Discussion of Redistricting of Elementary Students to Better Balance Central and East - Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mr. Held, the board voted and the motion carried to move students residing at Tilly Estates, Lamplight Manor and Tee Pee Trailer Court in Bicknell to the North Knox East Elementary School.

Employment of Elementary Teachers - Upon the recommendation of Superintendent Ringo and a motion of Mr. Sargent, seconded by Mrs. Villwock, the board voted and the motion carried to employ Shelli DeSchamp as fourth grade teacher at West Elementary and Amy Sloan as half-time elementary music teacher.

Building Level Reports - Each building principal gave a brief report as to the activities occurring within their respective building.

Next Meeting Date - Mr. Byrer stated the next regular meeting would be held on Tuesday, August 19, 1997, at 7:30 p.m.
