Approval of Minutes of September 17, 1996. Upon the recommendation of Superintendent Ringo and a motion of Mr. Rode, seconded by Mr. Sargent, the board voted and the motion carried to approve the minutes of the September 17, 1996, board meeting.

Request for Approval of Quote from Sonitrol Security Systems.
