**Approval of Minutes of April 18, 2000 Board Meeting and April 24 Executive Sessions** - Upon the recommendation of Superintendent Ringo and a motion of Mr. Held, seconded by Mr. Byrer, the board voted and the motion carried to approve the minutes of the April 18, 2000, board meeting and April 24 executive session.

**Financial Statement** - Mr. Sargent read the financial statement for the month of April..

**Approval of Claims and Authorization for Payment** - Payroll Numbers 16 &17 and Claim Numbers 1249-1387. Upon the recommendation of Superintendent Ringo and a motion of Mrs. Villwock, seconded by Mr. Byrer, the Board voted and the motion carried to approve and authorize payment of payroll numbers 16 &17 and claim numbers 1249-1387.
