**Bids on Resealing Parking Lots.** Superintendent Lavery stated 3 bids were received on resealing parking lots. Bids were received from WEP Asphaltting, Gaultney and Robison Striping.

Upon the recommendation of Superintendent Lavery and a motion of Mr. Richter, seconded by Mr. Hall, the board voted and the motion carried to accept the bid from Robison Striping in the amount of \$5,893.50 and \$5,480.00.

**Awarding of Bid on Temporary Loan.** Superintendent Lavery stated 4 bids were received on a temporary loan in the amount of \$2,000,000.00. Bids were received from Old National, Union Planters, First American and Bloomfield State Bank.
